- 1) The Chair called the meeting to order at 7pm and thanked those present for attending the meeting.
- 2) Apologies: The above apologies were received and given (Note: The meeting was quorate (minimum number of members to be present is 21 (or 20% of membership). 23 (7 officers) were recorded as present)).
- 3) Minutes: Quarter 1 Virtual Constituency Meeting held: 28th January 2022 Comment:

No comments were made, nor matters arising.

- a) The minutes were noted and signed by the Chair.
- 4) Officer's Reports:
 - a) Chair Mike Hewitson: See agenda pack for submitted report.

Comment: The Chair introduced his report by emphasizing the good results achieved at the County/Unitary Council elections held in May. The Chair thanked Thomas Gravatt for all his work as organiser to keep the momentum going and achieve the success we deserved. This was an excellent opportunity and a great platform from which to build and show what LibDems can do. The Chair moved on to the issue of PPC selection and what we need to do. The important thing is that we need a Returning Officer (RO) from outside the constituency. There is a shortage of ROs and 'eadministrators' and ROs can only run one selection at a time. Guy Adams (Regional Administrator) is the person charged with appointing ROs.



The Chair and others have prepared all the necessary y documents and they are prepared to go out as soon as an RO is appointed.

Questions were taken from the floor:

A suggestion was made about other documents that could be produced ready for the PPC selection.

Comments were made about regional priorities regarding PPC selections, getting out and recruiting/talking to people – Tiverton and Honiton was a great example of what can be done – we will need to do the same, with fewer resources. A comment was also made about resident's surveys with no prohibition and plenty of templates to call on, this was no problem if people wanted to do them.

Questions were asked about the availability of the RISO and a Newsletter for members.

Other comments from the floor included Postal Votes, communication with members, especially new members, employing an office person to look after the office.

The position of Organiser was clarified by the Chair in response to a question, with the Chair explaining that we now shared Thomas, and his costs, with S&F.

A constituency strategy re local comms was suggested.

A proposal was put forward to look at office communication and office management, to report back in September. The proposal was made by Adam Dance and Seconded by Gail Coleshill. Proposal:

'To establish a short-life Task and Finish Group (TFG) to look at Communications Strategy, particularly membership communications, office management and having a permanent presence in the Yeovil office. The TFG to report back to the Executive in September with a view to making a presentation to the AGM in October.'

The Constituency Meeting voted in favour of the proposal.

The following members indicated their willingness to form the TFG – Ray Buckler, Elaine Morris, Brian Hamilton and Gail Coleshill. Meetings to be arranged.

- b) **Treasurer:** The Treasurer was not present at the meeting. See agenda pack for summitted report and annual cashflow summary.
 - **Comment:** From the floor a member expressed concern about a red figure, another member commented about the lack of fund raising dur to Covid. The Chair pointed out that as a constituency looking for a PPC, we need to have an annual target of £100k.
 - A short discussion was held about various fundraising initiatives.
- c) **Membership & Branch Liaison Committee Chair: Position Vacant:** See agenda pack for submitted report from Gareth Thomas.

Comment: GT gave a statement to the meeting explaining why he had chosen to step down as Membership Secretary. In the statement he named a member of the Executive.

The member of the Executive responded to the statement.

The Chair reminded the meeting that we need to focus on winning the constituency back for the Liberal Democrats and come together. In doing this we need to find new members.

- d) Events and Fundraising Committee Chair: Judith Morris (JM): See agenda pack for submitted report. Comment: A short discussion was held about various fund-raising activities that can be initiated now we are beginning to emerge from Covid.
- e) Campaigns Committee Chair: Adam Dance (AD): See agenda pack for submitted report.
 - **Comment:** AD introduced his report and drew attention to the fact that, in some areas, if it hadn't been for the Green Party, we could have won. He went on to thank all the deliverers, door knockers and volunteers who helped in the campaign and the candidates for standing.
 - AD talked briefly about the successful Brympton by-election which saw Barbara Appleby returned, replacing the late Alan Smith. A good candidate and where people from all over Somerset came to help. AD told the meeting that there was a by-election happening in Mendip, all help welcomed.
 - AD also thanked all those who got involved in the Tiverton & Honiton by-election. It showed what Liberal Democrats can do when they put their mind to it. What seemed impossible, became possible because of everyone's efforts.



A short discussion was held about campaigning in general, including constituent communication, thankyou leaflets, boundary review, opposition parties, literature campaign.

- 5) Political Reports
 - a) **SSDC Report Val Keitch:** No report was submitted prior to the meeting.

Comment: VK was unable to attend the meeting and had asked Peter Seib, as deputy leader of SSDC to present on her behalf.

Peter explained to the meeting how busy it was now becoming at SSDC now the elections were out of the way and preparations were being made for the new Unitary Council in April next year. Things will only get worse and the officers were working hard to achieve success in the new Council.

The regenerations of Chard, Yeovil and Wincanton were touched on, as were 'Yeovil in Bloom'. The Street Scene teams were struggling due to Covid and illness throughout the authority and were being redeployed to help other areas.

Covid relief was available to businesses and details were on the website.

The Octagon theatre upgrade had reached another milestone and was ongoing.

Somerset Waste Partnership had received an award for their services.

A comment from the floor welcomed the Octagon upgrade but was concerned about the parking in the area.

- b) SCC Report Adam Dance: See agenda pack for submitted report.
 - **Comment:** AD opened the discussion by providing the meeting with brief overview of where the unitary preparations were, including LCNs, financial pressures (£44m shortfall in budget due to inflation and energy costs), Adult Social Care, Ofsted reports, phosphates, cost of living, public transport.
 - OP updated on scrutiny for Children's Services and pointed out that Schools in Somerset were among the lowest funded in the country.
- Westminster Report: No report was submitted for this meeting.
 Comment: A question was asked about the possibility of a by-election in Somerton and Frome. At the time of the meeting, this was not known.
- 6) Motions: No motions were brought to this meeting for consideration.
- 7) Topical Briefings: Parliamentary Spokesperson and Prospective Parliamentary Candidate (PPC) Chair.

3. Officer Reports

3.1 Chair's Report



I would like to take this opportunity to wish you a safe and happy 2023. We start this year with a greater degree of certainty than we have had for the last few years, we have elected 19 Unitary Councillors who will provide a strong Liberal Democrat voice for the next 4 years. With this stability and success comes some financial certainty for the Constituency about our income until 2027. This will allow the Constituency to plan and to build towards the next General Election.

We sadly said goodbye to our excellent organiser, Thomas Gravatt in December. Thomas has been involved in the 2019 District, 2019 General and 2022 Unitary Election campaigns as well as countless town by-elections, and has helped us to secure stunning success in Local Government. He may have single-handedly cut down a forest with a mountain of literature, but he has really helped us to deliver a strong and distinct local message. We would like to wish Thomas every success in the future as he and his fiancée Amy have just bought their first home together and have relocated to Southampton. We are about to commence the search for a new organiser, but there is no-one quite like Thomas. The Boundary Commission has published its 2nd draft of the 2023 Parliamentary Boundary Review, which will see Yeovil Constituency escape largely unchanged. Hamdon ward (Norton and Stoke) is the only ward which will move into the new Constituency of Glastonbury and Somerton. Further details on this change will be communicated by the central party as the year goes on. There is no need for any member to do anything as the party has systems and processes in place to manage these changes. The outcome of this process is a good result for Yeovil, and most Somerset constituency parties are happy that the changes overall give the party the best possible platform for the next General Election. The Conservatives are not happy with these changes, but the Electoral Commission are unlikely to make any further substantive changes, although the names of Constituencies may change, it would be highly unlikely for wards to change at this stage.

The Parliamentary Selection process is underway (again) with a new Returning Officer, David Hollingsworth appointed in December to pick up the process. David has met with



the Shortlisting Committee and has set out a timetable to the Candidates. This will take substantially longer than any of us would like but we have to follow the timetable to reduce the risk of an Appeal which could potentially put us back to the start all over again. You can be forgiven for likening this process to Snakes and Ladders, it is proving to be a major headache, but with the prospect of an early election now remote, it is more important to get the right candidate than to get a candidate right now. I've been working on this for over a year now, and I absolutely understand the frustration from members. I will be sending a separate note out to members on the subject of the Selection shortly.

Finally, please help us. We will be defending a Chard Town Council by-election in the next couple of months. It is vital that we defend solidly yellow territory against the Green Party. We will need to get regular canvassing and delivery sessions set up in the coming weeks. Please lend us a few hours to support our hard working Chard Town Council Group

3.2 Treasurer's Report



My apologies for not attending the meeting but I will be involved in a show that evening.

The figures below cover the last financial year (2022)

We started the year with an opening balance of £30493.80 and finished with a balance of £20732.42 which is an excellent result considering that we had a major election for the new Unitary Council during the year.

To go through the details, firstly on income

We still received £90.00 membership fees which the members had sent also to HQ but had not canceled their direct Debits which ended up as donations.

Councilor contributions £35737.54 represented 42.2% of the total income.

Grants and donations at £11682.81 (13.8%) were boosted by payments towards the election and contributions towards the new RISO machine.

Fundraising figure was a disappointing £1259.50 (1.49%).

Branch and Constituency income £35374.80 (41.77%) was made up of payments against printing/leaflets for other areas, part payment of our organiser with Somerton and Frome and a transfer of a wound up branch fund.

We received £539.64 (0.64%) from HQ against membership payments Totaling £84684.29.

Moving to our expenditure

The £1.60 was an account charge against a donation.

Rent on our Yeovil Office was £8400.00

Telecom cost were £718.46 covering the land line and wi-fi.

Energy Costs for Water gas and electricity were £992.87.

Office Costs were £10439.69 but this included 6K for the new RISO machine.

Postage costs were £1179.96

Meeting expenses of £291.00 (hall hires)

I passed £7202.14 to Brian our Agent for the election expenses.

We paid £28025.05 to our organizer but as I said earlier we split the cost for part of the year with Somerton and Frome.

Campaigning costs were £36810.92 but a large part of that was covered back to us by other constituencies especially as we ordered a Somerset wide leaflet which we distributed it via our Royal mail account.

Finally, we paid £384.00 in Fees to HQ

Totaling £94445.69



Moving forward we will benefit from not having an organiser in place at the moment and when we recruit a new one, we still hope to continue the part share of payment with S&F.

Councilor payments until March will include both SSDC and County but will make a significant drop when we move to a single Council from April.

With no large local elections for the next 4 years except bi-elections we must now focus on building funds towards the next General Election
